Manageability: Focus on Healing

- With Wyse thin computing your medical system is paperless--creating a faster, cheaper, more reliable system. Thus, eliminates the need to move files to where the patient is. Health care providers simply scan patient IDs bedside and everything is current and updated.
- All operating-system patches and installations as well as application installations and upgrades, are done in the data center so there is no need to touch every individual desktop.

Security: Wireless Regulatory Compliance

- Wyse thin clients are available with advanced security for wireless connections, ensuring security, compliance and privacy, including WPA, WPA2 and others. No thin client is superior for HIPAA compliance than Wyse.
- Because there is no local storage on Wyse devices, all back-up, data security, and application version control is dramatically simplified. Consequently, the loss of a unit no longer risks the loss of a patient's identity.
- With all data stored centrally, information can't be copied to external drives without administrator permission.
- Since all devices are log-in specific, it allows your organization to track and provision employee roles and access permissions
- Enhanced security features such as, biometrics and smartcard readers are available.

Lower Cost: Won't Strain your Budget or Staff

- Wyse devices consume as little as 1/20th the power of your average PC, giving your organization longer battery life for carts. This also allows nurses and caregivers to work an entire shift without having to stop to recharge their cart.
- Since thin computers do not require individual attention, fewer IT staff is required to maintain the devices, an average of 1:1,000 IT support to thin client ratio
